
Instruction to Tenderers and Conditions for qualification


1. The tender shall be received in two envelopes. Envelope 'A' shall contain eligibility qualifications and security money, the envelop 'B' shall contain "Financial bid" and shall be so marked on the left hand corner of the sealed envelope.
2. financial bid of only that Person/Agency/Caterer shall be opened whose qualification is found eligible for the same.
3. qualifications of Person/Agency/Caterer for consideration of running Canteen :
 - (a) Must have enclose experience certificate (if any) for running of Canteen etc.
 - (b) Must enclose proof of income tax and sales tax number.
 - (c) Must enclose Bank Draft/FD amounting of Rs. 50,000/- (Fifty thousand only) of National/Nationalized Bank duly pledge to the Registrar, J. P. University, Chapra.
4. Decision of the employer in regard to selection of Person/Agency/Caterer will be final and binding. The employer is not bound to assign any reason therefore.


